ABC1 - Ages & Stages Questionnaire: Social/Emotional 2 Comprehensive Seminar

ALL DAY SESSION – MUST ATTEND ALL 3 PARTS FOR STARS CREDIT

Early Childhood Educators are responsible for identifying, supporting and referring young children B-5 who may be at developmental risk. Participants will learn about the ASQ:SE-2, a parent and caregiver completed screening tool for social and emotional development. Discussions will include the background of the ASQ:SE-2 and how to use the tool in family child care, center-based settings, and home visiting to screen and support the social and emotional development of infants, toddlers, and preschoolers. Strategies for engaging families in the screening process and appropriate follow-up to the screening will be discussed. During this full day in-depth session, the participant will score and practice interpreting a sample questionnaire for a 6 month old. This tool can be used for the WV Tiered Reimbursement Program. **(Limited seating)**

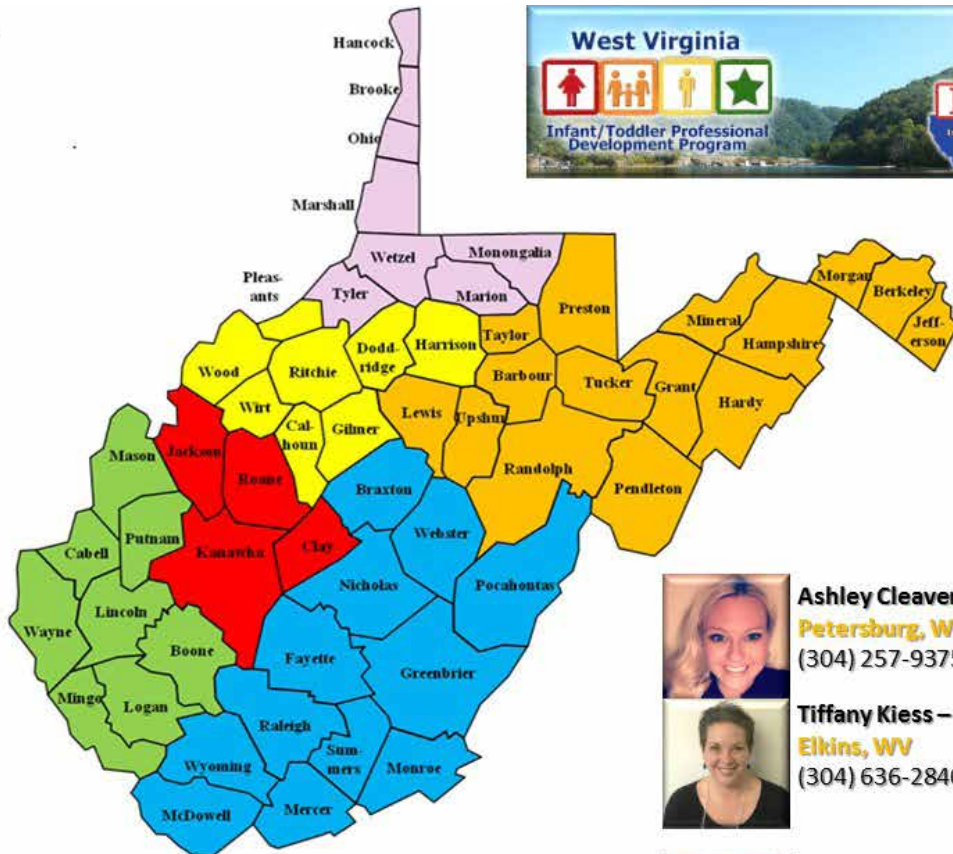
